BACKGROUND

In general: Council's road agency funded budget is funded by a financial Addendum to the Memorandum of Agreement (MOA) for a 3-year provincial financial year period, budgeted using estimated pro rata cash flows to compensate for the different financial years involved and annually adjusted based on the provincial financial year allocation funding period.

Council's 2020/2021 road agency budget is therefore funded by the following Addendum to the Memorandum of Agreements:

- Addendum to the MOA for the 2020/2021 financial year:
 - 1 April 2020 to 31 March 2021: R108 505 000.00
 - 1 April 2021 to 31 March 2022: R117 080 000.00
 - 1 April 2022 to 31 March 2023: R123 130 000.00

The full amount available is not transferred but monthly expenditure is reimbursed after submitting monthly claims to Province that includes the processing of the monthly expenditure into different standard activity codes and performance indicators making use of the provincial roads management system (IMMS).

Province further transfers a two-month advanced payment at the beginning of the provincial financial year (based on the original 2-month cash flow budget estimates) but also reimburses all monthly claims continuing monitoring the spending.

Annually Council is required to review and adjust the road agency funded budget after the 12-month provincial allocation period to allow for:

- Any remaining funds already transferred and not claimed by Council needs to be returned together with an adjustment (reduction) on the <u>current</u> Council's budget of the under-expenditure amount.
- Any over expenditure needs to be reflected on Council's <u>following</u> financial year budget with an adjustment (reduction) for the over expenditure amount (the over expenditure will be funded by the following provincial year allocation as reflected in the 3-year Memorandum of Agreement).

COMMENT

The following two MOA adjustments were also recently received affecting the original provincial funding available for the period 1 April 2020 to 31 March 2021:

- Addendum 1 to the MOA for the 2020/2021 financial year:
 - 1 April 2020 to 31 March 2021: R103 955 000.00
 - Due to Provincial COVID-19 related expenses
- Addendum 2 to the MOA for the 2020/2021 financial year:
 - 1 April 2020 to 31 March 2021: R100 000 000.00
 - Due to the continuous cumulative under expenditure up to 31 December 2020 (R7 775 371.57 based on the first reduction to R103 995 000.00). This under expenditure was mainly due to the ripple effect of the COVID-19 lockdown and relevant regulations affecting the civil industry returning to full production. It was also linked to the periods involved to fill the different budgeted vacant posts.

The impact of the adjusted reduced budget amount of R8 575 000.00 is therefore applicable to the MOA for the period 1 April 2020 to 31 March 2021 and represents two of Council's financial years:

- 2019/ 2020: April 2020, May 2020 and June 2020
- 2020 /2021: July 2020 to June 2021

Due to relevant financial legislation and the time periods involved it is not possible at this stage to finalise the March 2021 expenditure claim and therefore to perform an accurate adjustment based on an over or under expenditure.

To determine the impact of the R8 575 000.00 reduction on the available funding to Council and subsequent risk to Council based on all original and revised signed MOAs:

- This reduction forms part of the provincial funding period for April 2020, May 2020 and June 2020 (when an under expenditure of the estimated cumulative budget cash flow of R3 269 495.00 was applicable). The full impact of the reduction of the R8 575 000.00 therefore cannot be accommodated in Council's current financial year period (July 2020 to June 20201).
- R108 575 000.00 (provincial funding period for 1 April 2020 to 31 March 2021)
- R117 080 000.00 (provincial funding period for 1 April 2020 to 31 March 2021)

It can therefore be concluded that:

- Sufficient provincial funds are still available to cover the existing 2020/2021 Council road agency budget (R117 050 000.00).
- The revised estimated expenditure for January 2021 is R8 900 000.00 and for February 2021 is R15 300 000.00. The expected remaining funding for the provincial funding period is R1 805 371.57.
- All expenditure for the March 2021 is currently monitored to limit the expected over expenditure for the provincial funding period 1 April 2020 to 31 March 2021.
- Final annual review of the provincial 12-month funding period:
 - After finalising of the March 2021 expenditure claim that both Council's affected budgets (2020/2021 and 2021/2022) be adjusted if needed: for 2020/2021 (affecting 3/12 months of relevant MOA period) and 2021/2022 (affecting 9/12 month of relevant MOA period).
