- Section 11(g) Refund guarantees, sureties and security deposits; 6.
- 7. Section 11(h) Payments for cash management and investment purposes in accordance with section 13;
- 8. Section 11(i) - To defray increased expenditure on a multi-year capital project in terms of section 31;
- 9. Section 11(j) Payments for such other purposes as may be prescribed from time-to-time.
